Basic Services of Director, Staff and Overhead ..... \$200.00

Our services include conducting the arrangement conference, planning the funeral, consulting with family and clergy, shelter of remains, preparing and filing of necessary notices, obtaining necessary authorizations and permits, coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.
