The cost of other than local transportation in vehicles of funeral home is \$1.50/mile.

Direct Cremation

Our charge for direct cremation without any attendant, rite, or ceremonies includes:

Removal and shelter of the remains, local transportation to crematory, cremation container (unfinished wood box), necessary authorizations, and overhead expenses.

If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).



PLEASE NOTE: Cemeteries and crematories may have certain restrictions concerning the type of burial or cremations container they will accept. These facilities may require the use of an outer burial container and may have other rules, regulations and restrictions which may limit your choices or require you to purchase certain goods or services.

Payment Policy

If legal or other requirements mean you must buy any items that you specifically did not request, we will explain the reason(s) in writing on the statement we provide describing the funeral goods and services you have selected. This list *does not* include prices for certain items that you may ask us to purchase on your behalf, such as cemetery or crematory services, flowers and newspaper notices. The prices for those items will be listed in your bill or the statement describing the funeral goods and services you have selected. (We charge you for our services in purchasing these items.)

Services of the Funeral Director / Staff \$1.600.00

This professional service charge includes, but is not limited to, the following:

- * Consultation with the family, arrangement and direction of funeral ceremony.
- * Preparation and filing of necessary notices, authorizations and consents
- * Collecting Vital Statistics for Death Certificate, and filing death certificate.
- * Other services and staff attendance prior to, during and following the funeral including coordination with those providing other funeral related services (e.g., clergy, musicians, cemetery, crematory, physicians, medical examiner)
- * Staff availability 24 hours a day
- * Recommendations of obituary announcements
- Processing Life Insurance Claims (There is a 7% charge on any insurance processes)
- Preneed Account Setup (Account Setup fee of 5%)
 Storage Fee for undisposed human remains after 15 days after services are rendered: \$30/day

This fee will be added to the total cost of the funeral arrangements selected. This fee is already included in our charge for direct cremations, immediate burials, and forwarding or receiving remains.

Embalming*



Except in certain special cases (please see Michigan law requirements set out below), embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you choose not to have embalming, you generally have the right to choose an arrangement which does not require you to pay for it (e.g., direct cremation or immediate burial). Michigan law requires embalming when death is caused by certain infectious disease(s) or, with very limited exception, when the body is not taken to its final destination (e.g., cemetery or crematory) within 48 hours. If a public service/visitation is selected, embalming will be necessary.
